## CPFPA MEMBER REQUIREMENTS FOR COMPLIANCE

**Fire Protection Associations are governed according to the rules of the National Veld and Forest Fire Act (No. 101 of 1998). In summary, the Act describes the duties and obligations that landowners must undertake in order to comply with the NVFFA legislation. Every owner on whose land a veldfire may start or burn or from whose land it may spread must comply with these requirements.**

**Equipment Requirement:** Dependent on the size of the property, a landowner is required to have certain items of equipment. The CPFPA Rules classes these requirements into three categories, based on size parameters (1-10Ha; 10-100 Ha; 100 – 1000 Ha).

**Personnel & protective clothing:** As with the previous requirement, based on the same property size parameters, landowners require a certain recommended number of trained personnel to fight fires. It is recommended that the number of PPE/PPC is equal to the number of trained personnel designated to fight fire on the property, as without adequate protective clothing, personnel cannot be reasonably expected to fight fires. For personnel to fight fires, they should have received basic veldfire-fighting training.

**Training:** This is a prerequisite for all personnel who intend fighting fires.

**Firebreaks:** Firebreaks are required wherever the urban edge meets rural land. Every landowner on whose land a veldfire may start or burn from must prepare and maintain a firebreak on his side of the boundary between his land and adjoining land. No landowner within the Metro is allowed to use burning, hoeing or bulldozing to create or maintain firebreaks.

### **Invasive Alien Vegetation Removal, Management and Control**

This forms an important preventative measure as invasive alien vegetation increases the fire intensity, fuel load and exhausts available firefighting resources. According to the CARA Act No 43 of 1983, as well as the NEMBA Act No 10 of 2004, landowners are obliged to clear invasive alien vegetation growing on their properties.
